



TF1700 (2.5 METRE) AND TF1701 (2.0 METRE)

UNIVERSAL EXPEDITION AWNING

FITTING INSTRUCTIONS

Both the TF1700 & TF1701 are identical bar the 0.5 metre length difference, with the longer TF1700 being suitable for longer vehicles, roof rack length allowing.

On opening the zipped grey case, you'll find that the extruded aluminium mounting system is permanently attached to the case. In addition, enclosed will be a grey bag containing the fitting kit (selection of M6 bolts and Nyloc nuts), a 10mm ratchet spanner and two guy ropes with ground pegs.



On the rear of the base extruded aluminium mounting are two T-Slot grooves running the length of the mounting, along which you can slide the M6 hex head bolts to any position. This mounting is attached to the vehicle horizontally and attached to roof rack legs etc. It's not recommended to mount the awning using the gutter only as the weight of the awning will deform the gutter.

The T-Slot grooves are 48mm apart, measured centre to centre. You'll need to drill 2 x 6mm holes in each upright roof rack leg, each 48mm apart – please note the importance of ensuring that every hole is not only the correct distance apart from each other but that each pair of holes in every leg is in line horizontally with each other on every supporting roof rack leg.

Once the holes are drilled, slide an equal number of bolts in to each of the upper and lower T-Slot grooves, space them out to match the roof rack leg spacing, offer up the awning base to the legs, ensure the threaded ends of the bolts protrudes through its relevant hole and fasten in place with the Nyloc nuts and ratchet spanner provided.
